Trade/Industry:

- (i) Reduction in multiplicity of taxes
- (ii) Mitigation of cascading/double taxation
- (iii) More efficient neutralization of taxes especially for exports
- (iv) Development of common national market
- (v) Simpler tax regime-fewer rates and exemptions
