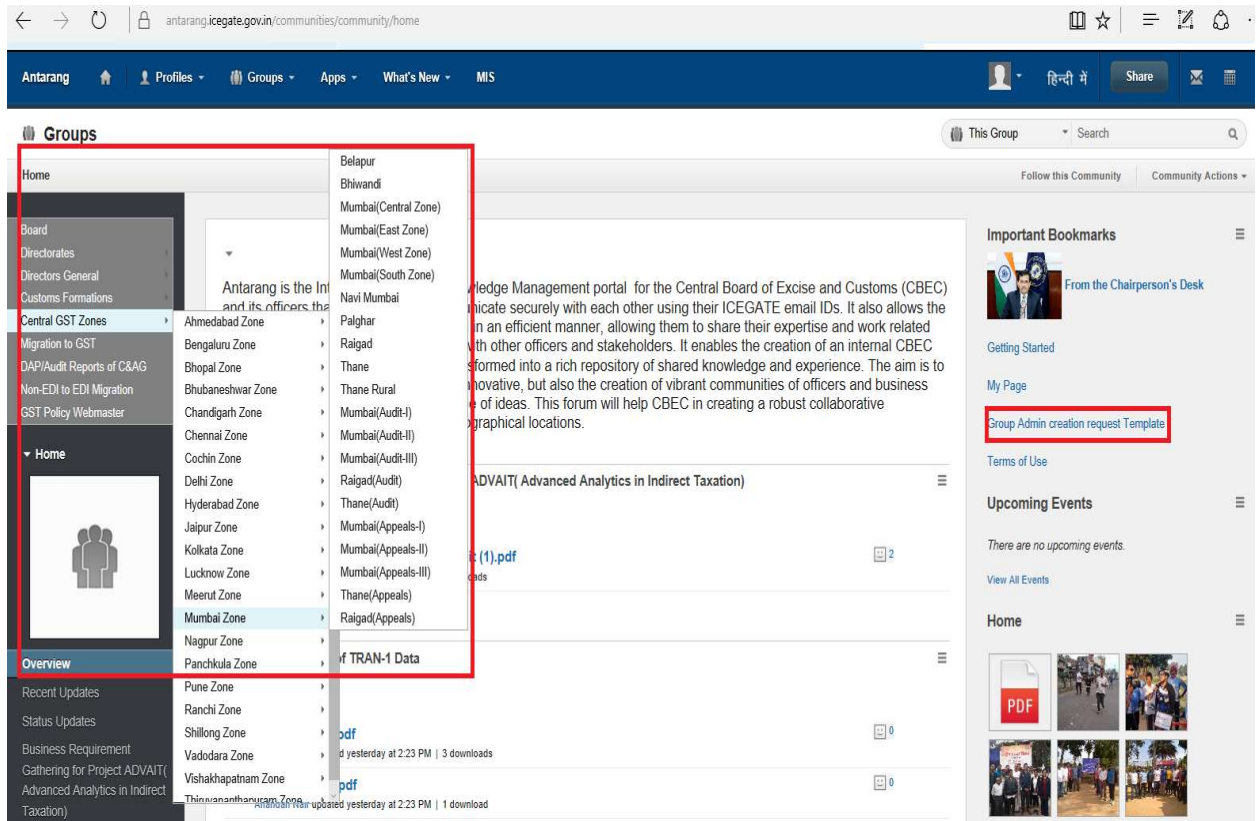


Zone wise communities on Antarang for intra zone file-sharing. Steps to add members in these communities and to nominate the ACL Admin as owner of the community are given below:

1. Zone, Commissionerate (Executive/Audit/Appeals) and Division/Circle wise Communities have been created on Antarang to enable internal file sharing at Zone, Commissionerate and Division level as highlighted below.



The community file sharing is useful as there is no limit on file size unlike an email. It does away the need to use USB drives or private drives like Google for data transfer as sharing government revenue data on private drives is not secure and use of USB drives causes threat of spread of malware or virus. This community enables file sharing upto 500 MB which can be extended in the multiples of 500 MB by sending a request on webmaster.antarang@icegate.gov.in. Such file sharing groups provide a secure and efficient platform to share documents within a group of officers in a particular jurisdiction and once the officers are added in a group the document shared can be received by all of them in one go.

To nominate the ACL Admin as the Group Admin who is responsible for addition of members at Commissionerate level in a community, the 'Group Admin creation request template is to be filled and sent to webmaster.antarang@icegate.gov.in

Once the Group Admin has been activated, members can be added at Commissionerate level as shown below

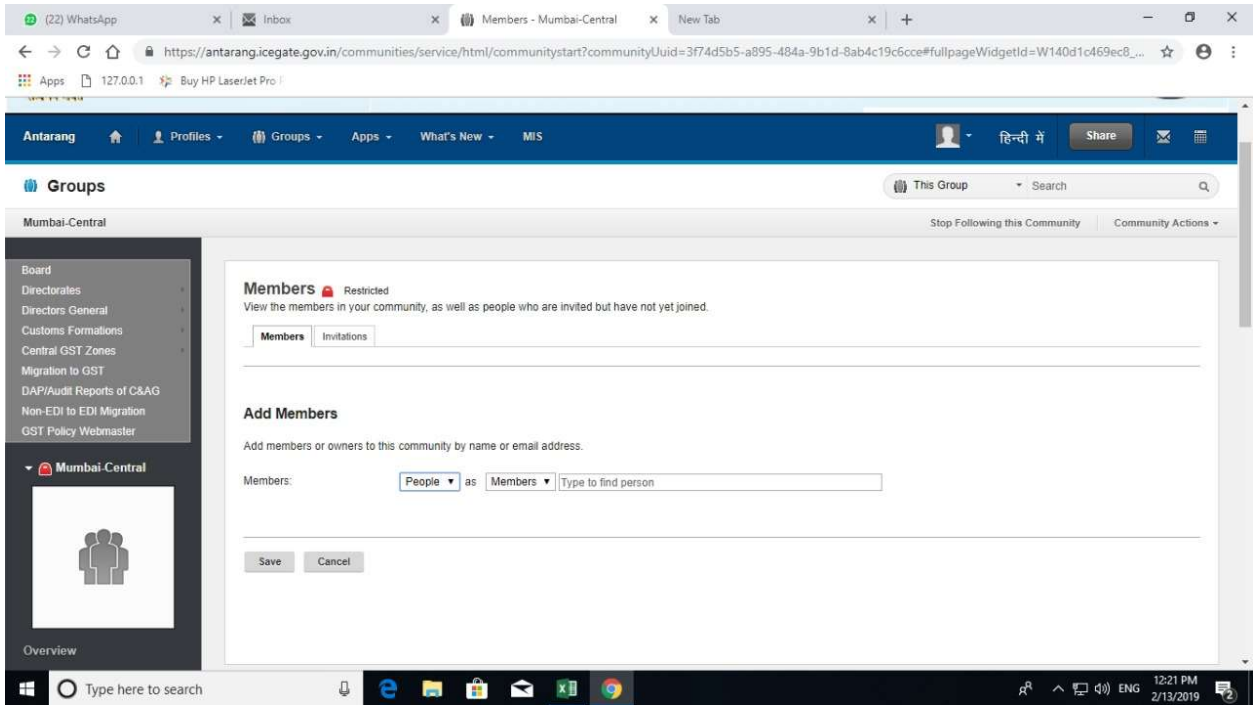

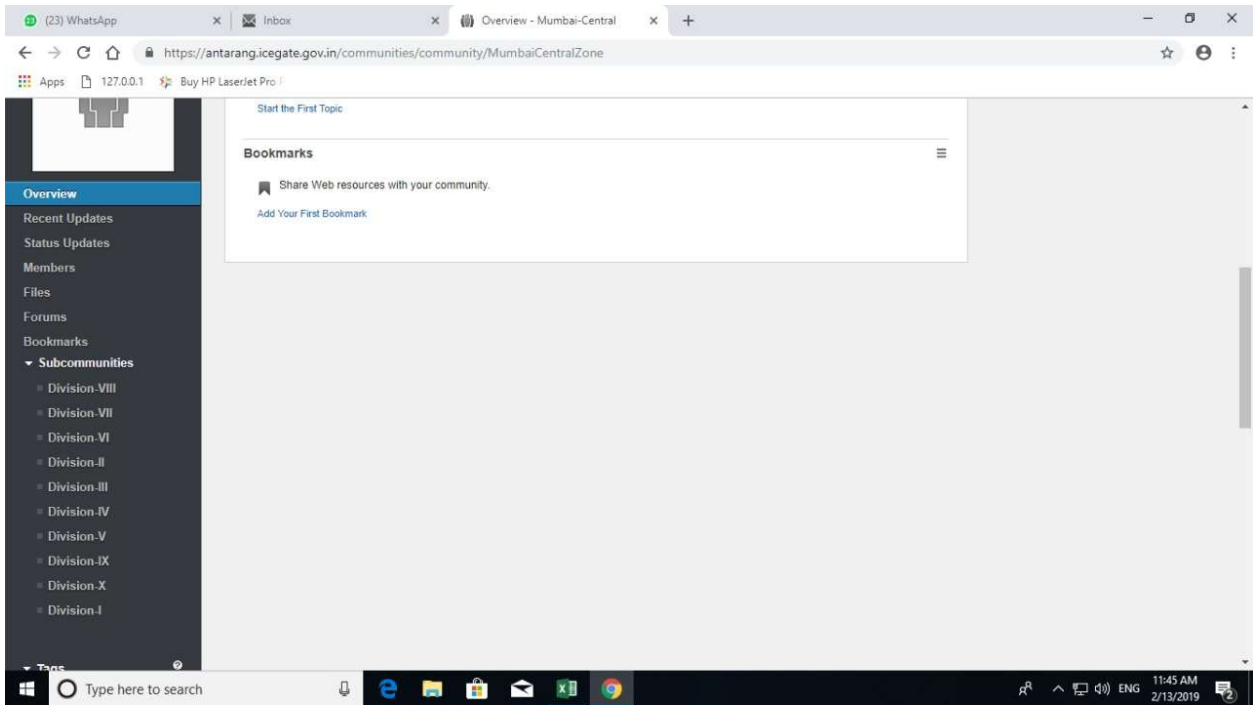
