TRADE NOTICE NO. 02/2025-CENTRAL TAX

Sub: Territorial re-organisation of GST Divisions and Ranges within the GST Commissionerates in the Hyderabad Zone - Reg.

Date: 29.04.2025

Reference is invited to the Trade Notice No. 01/2017-Central Tax dated 21.06.2017, issued by this office wherein consequent upon issuance of Notification No. 02/2017-Central Tax dated 19.06.2017 by the Government of India, the jurisdiction of the Commissionerates, Divisions and Ranges falling under this Zone were brought to the notice of the taxpayers and trade.

- 2. Territorial jurisdiction of Divisions and Ranges within Commissionerates has been reviewed. Keeping in view administrative convenience, addition of new Taxpayers and uneven Taxpayer distribution among existing jurisdictions, it has become imperative to re-organise certain Divisions and Ranges within the existing Commissionerates of this Zone. Accordingly, the amended names, wherever applicable, and the new/ revised territorial jurisdictions of Divisions and Ranges of Executive **Commissionerates** respective viz., **Hyderabad** Commissionerate, Medchal Commissionerate, Rangareddy Commissionerate and Secunderabad Commissionerate, is detailed in the Annexures I to IV to this notice, respectively.
- 3. Re-organisation, as above, shall come into effect from 01.05.2025.
- 4. The taxpayers / trade are requested to carefully note the amended jurisdiction of the Divisions and Ranges. All the members of the Regional Advisory Committee and Trade Associations, Chambers of Commerce in the State of Telangana are requested to circulate this Trade Notice among their constituent members for information and guidance.

- 5. In order to ensure that difficulties, if any, consequent to reorganisation are minimized, the transition/re-mapping shall tentatively take place on 24-25th May, 2025 (Saturday & Sunday). This will ensure that the return filing cycle for the month of April, 2025 is over before the transition/re-mapping takes place.
